### *Physical Locations & Facilities*

On the first floor, there is the lobby, two lecture halls and a meeting room with sophisticated audiovisual equipment, as well as the office suite for the Titus Family Department of Clinical Pharmacy. On the second floor is the Walgreens Conference Room, a meeting space with modern technology, and several faculty offices and research labs. The third floor is home to offices and laboratories as well as small meeting rooms and a recently renovated student lounge. The fourth, fifth, sixth and seventh floors house faculty and staff offices and research laboratories. The School's Administrative Offices--including the offices of the Dean and the Senior Associate Dean for Academic & Student Affairs--are located on the seventh floor. ## **PART A: ACADEMIC POLICIES & PROCEDURES**

### **Section I. TECHNICAL STANDARDS**

#### **Policy**

The candidate admitted to and enrolled in the University of Southern California (USC) Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences (USC Mann) Doctor of Pharmacy (PharmD) program, herein referred to as “candidate,” must meet and continue to meet throughout their enrollment, the Essential Technical Standards set forth in this policy. USC Mann is committed to full compliance with the Rehabilitation Act (Section 504) and the Americans with Disabilities Act (ADA) and related state and federal laws. USC Mann also abides by the USC’s policies on [Disability Accommodations](#) and [Non-discrimination](#). The Essential Technical Standards are not intended to deter any candidate for whom reasonable accommodation will allow the fulfillment of the complete curriculum.

Audience: All current and prospective PharmD candidates of USC Mann

#### **Procedure**

1. The candidate entering and continuing in the USC Mann PharmD program must demonstrate that they meet all the Essential Technical Standards outlined herein with reasonable accommodation if necessary, and each candidate will be expected to certify that they meet these standards.
2. The candidate returning from any leave of absence must recertify that they continue to meet the Standards.
3. If at any point during enrollment the candidate’s ability to meet these Standards is compromised, it is the candidate’s responsibility to report this change to the USC Mann Office of Student Affairs.
4. The candidate who requires an accommodation at any time throughout their enrollment with USC Mann must seek approval from the appropriate School or University office (e.g., [Office of Student Accessibility Services \(OSAS\)](#)). Those who receive accommodations must submit the notice of approval to the USC Mann Student Affairs. Candidates who fail to provide necessary documentation to USC Mann may not receive accommodations.
5. In most cases, the implementation of accommodations is simple and requires no further action on the part of the candidate. For more complex accommodations, the USC Mann Student Affairs will work with the candidate and the OSAS to ensure that the accommodation is fairly and consistently provided without fundamentally altering the nature of the academic program. The candidate is expected to answer reasonable questions related to the implementation of accommodations when asked.
6. If the School has reason to question the candidate’s certification that they meet the Essential Technical Standards, USC Mann can require that the candidate undergo an evaluation and review by the USC Mann Student Affairs to determine whether the candidate is able to meet these Standards.

# ESSENTIAL TECHNICAL STANDARDS REQUIRED FOR COMPLETION OF THE DOCTOR OF PHARMACY DEGREE AT USC MANN

## PREAMBLE

The PharmD program consists of 4 years of study, including didactic, practice-based, service, and co-curricular learning. Graduates of the USC Mann PharmD program are required to demonstrate both competency in pharmacy practice for pharmacist licensure and achievement of the [USC Mann Trojan Pharmacist Outcomes](#).

USC Mann has an ethical responsibility for the safety of patients with whom the candidate will come into contact both before and after graduation. Therefore, patient safety is a major factor in establishing requirements for the candidate for program admission, advancement, and completion.

Essential Technical Standards for completion of the PharmD degree require reasonable assurance the candidate can successfully complete the entire course of study and participate fully in all aspects of training. The candidate of the PharmD program must possess intellectual, ethical, physical, and emotional capabilities necessary to undertake and to achieve expected levels of competence in the full curriculum. An avowed intention to practice in a particular specialty or practice setting following graduation does not alter the requirement that the candidate complete and achieve competence in the full curriculum.

Participation in the curriculum requires licensure as an Intern Pharmacist in the State of California throughout the four years of the program. The ability to obtain and maintain Intern Pharmacist licensure is required for participation in the PharmD curriculum. If a candidate is participating in a clinical rotation in another state, they will also be required to obtain licensure for that state. The candidate will be required to submit to and pass background checks, including those of criminal activity, and drug testing to participate in the practice-based learning.

## I. PERFORMANCE REQUIREMENTS

After reasonable training and experience, the candidate must be able to observe and participate in demonstrations and experiments in the basic and clinical sciences, including but not limited to manipulation of needles, syringes and instruments related to sterile product preparation and vaccination, visual and physical examination of pharmaceutical products, and microscopic studies. After reasonable training and experience, the candidate must be capable of performing a limited physical examination, including observation, palpation, percussion and auscultation. The candidate must be capable of using medical instruments (e.g., stethoscope, ophthalmoscope, otoscope, sphygmomanometer). The candidate must be capable of performing basic laboratory exercises, using a calculator and a computer, and reading and interpreting common documents (e.g., medical records, laboratory reports, medications orders/prescriptions).

Practice-based experiences take place in settings such as community pharmacies, hospitals, and clinics where exposure to topical/airborne substances (e.g., medications, pathogens, perfumes etc.), noise (e.g., conversation, ringing of phones, medical equipment alarms, etc.) and distractions (e.g., movement of people, equipment, and lighting changes) are present. The candidate must be able to calculate, evaluate, determine a course of action quickly, perform tasks such as preparing medications and intravenous solutions, checking the work of technicians, and communicating with patients and healthcare providers in this type of setting. The candidate must also be able to move in the clinical setting to act quickly in emergencies including being able to perform (and be certified in) Basic Life Support.

## **II. COMMUNICATION**

The candidate must be able to communicate with and receive communication from others, both verbally and in writing. The candidate must also be able to observe patients to elicit information, describe changes in mood, activity, and posture, and perceive nonverbal affective and gesture communication. These communication skills also must enable the candidate to obtain information from others in a timely fashion and to communicate effectively, efficiently, and sensitively with all members of the health care team, other professionals, patients, and their families. The candidate must be able to produce written materials and perform oral presentations.

## **III. CONCEPTUAL, INTEGRATIVE AND QUANTITATIVE ABILITIES**

The candidate must be able to assimilate detailed and complex information in the PharmD curriculum and in medical literature. The candidate must be able to evaluate complex problems and make decisions quickly. The candidate must be able to measure, calculate, reason, analyze and synthesize information across modalities.

## **IV. BEHAVIORAL AND SOCIAL ATTRIBUTES**

The candidate must possess the emotional health, maturity, and self-discipline required for full use of one's intellectual and judgmental ability and for successful participation in, and the completion of, the course of study leading to the PharmD degree. These include but are not limited to attendance, integrity, honesty, conscientiousness in work, and teamwork. The candidate must accept responsibility for their mistakes and for their own learning, exercise good judgment, and promptly complete responsibilities. The candidate must be capable of interacting with patients and health care personnel in a caring, and compassionate manner, be attentive to details, adapt to changing environments and display flexibility. The candidate must be able to access these skills when physically taxed and when working under stress, which may include some nights and weekends during practice-based experiences.

## **V. SAFETY**

USC Mann has a responsibility to consider the safety and welfare of patients and others. Should the candidate have a condition that would place patients or others at significant risk, that condition may be the basis for denial of admission or dismissal from school. The candidate must be able to comply with all requirements (including vaccination and other health requirements) to participate in all educational settings.

### ***CLINICAL ROTATION BACKGROUND CHECK AND RELEASE:***

The successful completion of clinical experiential rotations with healthcare providers/facilities unrelated to the University of Southern California ("USC") didactics is a requirement for obtaining the Doctor of Pharmacy PharmD degree at USC. In order to determine your fitness to participate and as a condition of participation in clinical rotations, the sponsoring healthcare provider/facility may require that you consent to a criminal background check, drug screening test and/or to provide fingerprints. If you refuse to consent, fail to fulfill the fitness for participation requirements of the sponsors of the clinical rotations, or are denied participation in the clinical rotation, you will be unable to qualify for the degree that you are seeking at USC. However, by consenting to the fitness for participation requirements of clinical rotations sponsors does not guarantee acceptance in any clinical rotation or the awarding of the degree you are seeking.

The areas of inquiry typically covered in the background check by USC's clinical partners are:

- A seven-year criminal court history
- Address verification

- Sex offender database search
- Two names verification (current legal and one other AKA names)
- Three county check of records
- Office of Inspector General (OIG) Search
- Social security number verification

Background checks are required for admission to the Doctor of Pharmacy program, as well as subsequent background checks throughout the academic year. Fingerprints (LiveScan) are required for licensure by the California State Board of Pharmacy, and licensure is required for participation in the Doctor of Pharmacy program.

## Section II. STUDENT ACCOMMODATIONS

The University of Southern California is committed to full compliance with the Rehabilitation Act (Section 504) and the Americans with Disabilities Act (ADA). As part of the implementation of this law, the university will continue to provide reasonable accommodation for academically qualified students with disabilities so they can participate fully in the university's educational programs and activities. USC is not required by law to change the "fundamental nature or essential curricular components of its programs in order to accommodate the needs of disabled students," however, the university will provide reasonable academic accommodations. It is the specific responsibility of the university administration and faculty serving in a teaching capacity to ensure the university's compliance with this policy.

According to the Americans with Disabilities Act as Amended (ADAAA 2008), "an individual with a disability is someone who experiences or lives with an impairment that substantially limits one or more major life activities, or who is regarded as, or has a history of being regarded as, an individual with disability".<sup>1</sup>

*A. ACADEMIC ACCOMMODATIONS:* The University has designated the [Office of Student Accessibility Services](#) (OSAS) as the unit responsible for ensuring equal access for students. Equal access is typically provided via approved accommodations and auxiliary aids for use in classrooms, course-related testing, housing, dining, events and activities, fieldwork/clinical placements, and physical/architectural settings. OSAS reviews appropriate medical documentation, and consistent with laws and best practices, determines reasonable accommodations, as well as auxiliary aids and services.

Students seeking academic accommodations due to a physical, psychological or learning disability should submit an application to OSAS prior to the start of the semester (or for new situations, as early in the semester as possible). Instructors will require students to present documentation from OSAS when academic accommodations are requested. USC Mann has definite policies for academic accommodations as specified in its *Essential Technical Standards Policy*.

Reasonable academic and physical accommodations include but are not limited to: extended time on examinations; substitution of similar or related work for a non-fundamental program requirement; time extensions on papers or projects; special testing procedures; advance notice regarding booklists for visually impaired and learning disabled students; use of academic aides in the classroom such as note-takers and sign language interpreters; accessibility for students who use wheelchairs and those with mobility impairments; and need special classroom furniture or special equipment in the classroom.

**B. PROCEDURES FOR OBTAINING ACCOMMODATIONS:** Students requesting accommodations are encouraged to contact OSAS and [complete the application](#) prior to or as early in the semester as possible. Once registered for their courses, it is the student's responsibility to complete the OSAS application and provide medical documentation verifying disability to OSAS. The application process may take several weeks, so students are encouraged to apply as early as possible. OSAS provides final approval. It is then the student's responsibility to provide the OSAS accommodation letters to Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)), Jennifer Lang, Program Administrator ([hsujenni@usc.edu](mailto:hsujenni@usc.edu)), and any Course Coordinator(s) for courses that students desire accommodations, no later than one week prior to when the accommodation is first needed for the course. OSAS letters are required for all course accommodation requests. The designated OSAS Coordinator for USC Mann is Dr. Cory Reano, Director of Student Success and Engagement.

Please note that the National Association of Boards of Pharmacy (NABP) administers the Pre-Naplex and Naplex exams. Accommodation requests are to be made directly with NABP. Please follow the [request for testing accommodations](#) instructions on the website.

### **Section III. ABSENCE POLICIES**

- A. RELIGIOUS OBSERVANCE:** University policy grants students excused absences from class for the observance of [religious holy days](#). Faculty are asked to be responsive to requests when students contact them IN ADVANCE to request such an excused absence. The student should be given an opportunity to make up missed work because of religious observance. Faculty are asked to be responsive to requests when students contact them IN ADVANCE to request such an excused absence. - B. MISSED EVALUATIONS:** A missed examination, quiz, or other assignment will be graded as zero "0" by the course coordinator/instructor. Exceptions may be made for the following situations:
1. If a student has a short-term personal emergency, the student should make every effort to notify the Course Coordinator PRIOR to the start of the evaluation. Requests for excused absence due to short-term personal emergencies are reviewed and approved by the Course Coordinator. If the student is not able to make immediate contact, they must make contact as soon as possible (preferably within 24 hours) with the Course Coordinator after the start of the evaluation. The

student is expected to work directly with the Course Coordinator to reschedule the missed evaluations. Short-term personal emergencies are defined as:

- any communicable illness (e.g. flu)
- serious vehicle accidents
- hospitalization
- serious illness or physical injuries which require emergency medical treatment

The student may contact Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)) if they need assistance in contacting the Course Coordinator regarding short-term personal emergencies.

2. If a student has an extended excused absence (not more than 1-2 weeks) due to a personal emergency (e.g., illness requiring quarantine), the student must contact both the Course Coordinator and Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)). Requests must be verified in writing by Student Affairs (e.g., copy of documentation) before approval may be granted. If approved, Student Affairs will notify the Course Coordinator and request to allow the student to makeup work without penalty. Students with absence requests that extend beyond the approved two weeks will need to apply for accommodations through OSAS.
3. If a student is participating in holy days, civic procedures, citizenship interviews, and necessary medical procedures, the student must contact the Course Coordinator in advance of the absence and provide verification to Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)).
4. If a student learns of the sudden death of a family member (e.g., spouse, child, mother, father, sister or brother), student should notify the Course Coordinator and Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)). Total bereavement of up to 5 days may be approved.

For reasons 1,2,3 & 4, Course Coordinators should make every effort to allow students to make up missed work without penalty.

5. If a student has a significant pre-scheduled event which conflicts with an evaluation activity, the student must contact the Course Coordinator two weeks prior to the evaluation to obtain approval for a rescheduled evaluation. Recognize that approval will unlikely be granted. All PharmD students are expected to take part in all degree requirements each semester and should avoid making personal plans that conflict with these requirements.
6. If a student misses an evaluation for any other reason, an approval will unlikely be granted.

For reason 5 & 6, Course Coordinators have the following options if request is granted:

- administer a make-up evaluation activity. The Course Coordinator has the option to administer a mark of “C” as the highest grade in that evaluation activity.
- Excuse the student from completing the evaluation activity.

### C. *INCLEMENT WEATHER POLICY*

Should conditions occur making travel potentially dangerous, you are reminded to use your own good judgment before venturing out. Any decision to cancel classes – or to close the University or a regional campus or medical center – will be made after University officials have consulted on the condition of campus roads and grounds as well as conditions in the vicinity. Notifications will be made through the LiveSafe Mobile app, TrojansAlert text messages and posted at: <https://www.usc.edu/emergency/>

Students who are working in patient care areas or in clinical rotations should check with their dean, program director or clinic manager. A declaration of a weather emergency by the governor or city officials does not automatically close USC campuses or medical centers.

- D. **MAKE-UP FINAL EXAMINATIONS POLICY:** No student is excused from a final examination. When a final examination falls at a time which conflicts with a student's observance of a holy day, faculty members must accommodate a request for an alternate examination date at a time that does not violate the student's religious creed. The student must discuss a final examination conflict with the professor no later than two weeks prior to the scheduled examination date to arrange an acceptable alternate examination date.

Note: Days may not be requested to study for an exam because of time taken off for religious observance.

## Section IV. DEGREE REQUIREMENTS AND POLICIES

Students in the Doctor of Pharmacy program are subject to the following policies and procedures on scholarship standards. Unlike degree requirements, changes in regulations, policies and procedures are immediate and supersede those in any prior bulletin. Students are also expected to be familiar with the University's academic policies as published in the *University of Southern California Catalogue*.

### 3. OTHER GRADES

#### a. Grades of “IN” (Incomplete)

The grade “IN” (incomplete) is assigned for work not completed in a course because of documented illness or some other emergency occurring after the twelfth week (or equivalent) of the semester. Arrangements for an “IN” must be initiated by the student and agreed to by the instructor prior to the final exam. Students must fill out an [Assignment of Incomplete Form](#) and send it to the instructor for completion prior to the end of the semester. The instructor will provide a copy of the completed form to the student and to Student Affairs. The instructor will list the work that must be completed to earn a final grade. Pending work must be completed within one calendar year from the end of the semester in which the IN was assigned. A student can only remove grades of “IN” (Incomplete) by satisfying all stipulated requirements for the course(s). A student may not remove grades of “IN” (Incomplete) by re-registering for the same course. Unresolved IN will default to a mark of IX (Expired Incomplete) after one year. The instructor will submit a grade change request to Student Affairs once all the required work has been completed.

#### b. Grades of “IX”

Expired incomplete “IX” is automatically assigned when the student has not completed requirements for removal of an “IN” within the specified time limit. An “IX” is calculated into the grade point average as zero grade points. A course offered on a “CR/NC” basis for which a mark of Incomplete is assigned will lapse with a mark of “NC” and will not be calculated into the grade point average.

#### c. Grades of “UW” (Unofficial Withdrawal)

The grade of “UW” (Unofficial Withdrawal) is assigned when a student stops attending class without officially withdrawing. The “UW” is computed as a “NP” (No Pass) and indicates a failure. It is the student’s responsibility to officially withdraw from class.

#### d. Grades of “MG”

A “MG” (Missing Grade) is an administrative mark assigned by the instructor. The mark should only be assigned in unique or unusual situations such as when a student is undergoing a review for a conduct or academic integrity issue. A final grade will be entered when the academic integrity case is resolved.

#### e. Grades of “IP” (In Progress)

The In Progress (IP) grading option is applied to a course approved by the university as one that exceeds one semester. The IP grade will update once the student completes the requirements for the course.

### B. RECONCILIATION OF GRADES

#### 1. OPTION TO RECONCILE GRADES OF “C+” AND “C”

- a. To repeat a course in which a grade of “C+” or “C” was obtained, a student must first receive prior approval from the USC Mann Scholarship Standards Committee. Second, a student must

file a petition and receive approval from the USC Committee on Academic Policies and Procedures (CAPP) prior to re-registering in the course. Post hoc approval will not be granted.

- b. Both the original “C+” or “C” and repeat grades will be used to calculate the grade point average (GPA). Students may not count the additional units for repeated or duplicated courses towards their degree requirements.
  - c. No student may repeat a course in which a grade of “B-” or better was received.
2. RECONCILIATION OF GRADES OF “C-” OR BELOW, “NC”, OR “IX” IN REQUIRED COURSES
- a. Remedial courses are not offered in the USC Mann didactic curriculum, but a student may be eligible for remediation as described under Remediation Policy.
  - b. If any grade of “C-” or below, “NC”, or “IX” has been assigned in any required course, a student must re-register and repeat the course at its next regularly scheduled period.
  - c. A P1, P2, or P3 student who is required to repeat a course will be automatically placed on a “Delay in Progression” status. Delay in Progress means that the student will not progress to the succeeding academic year until all courses are completed. For example, all required didactic P1 courses must be completed before a student can progress to their P2 year. Whether or not a student may progress to their assigned IPPE will be reviewed on a case-by-case basis.
  - d. A student will not meet the requirements for progression to the succeeding academic year for the PharmD program if a “C-” or below or “NC” grade in a course has not been officially reconciled.
  - e. When a student repeats a USC Mann course in which a grade of “C-” or below was obtained, both the original and repeated grades will be included in the computation of the grade point average, but the additional units for the repeated courses will not count toward fulfillment of unit and course requirements for the Pharm.D. degree.
3. RECONCILIATION OF GRADES OF “C-” OR BELOW, “NC”, OR “IX” IN ELECTIVE COURSES
- a. A student who receives a “C-” or below or “NC” in an elective course is required to register for and complete another elective (may be the same course or a different course) course.
  - b. The student is required to earn a “C” or better in a letter graded course and “B” quality or better in a non-letter graded course with a cumulative grade point average of 2.50 or better in elective coursework to meet graduation requirements.
4. RECONCILIATION OF GRADES OF “NC” IN INTRODUCTORY AND ADVANCED PHARMACY PRACTICE EXPERIENCES (IPPE and APPE)
- a. A student who receives a grade of “NC” in a required IPPE or APPE course must repeat the course. The repeat course site/preceptor will be assigned by the Office of Professional Experience Programs. A repeated required IPPE or APPE course will be assigned on a space available basis. The student must meet the performance criteria on the evaluation form to receive “Credit” for the repeated IPPE or APPE course.

- b. A student who receives a grade of “NC” in an IPPE or APPE elective course will be required to take an additional IPPE or APPE elective course when space is available. The student may register in a different IPPE or APPE elective or repeat the same elective subject to approval by the Office of Professional Experience Programs. The student must meet the performance criteria on the evaluation form to receive “Credit” for the additional IPPE or APPE elective course.
- c. A student who is required to complete a required or elective APPE course after block 8 must register for the APPE course. The student is responsible for paying all applicable tuition fees to be provided workman’s compensation and liability coverage while on rotation.
- d. A student who receives two grades of “NC” in any IPPE course will be disqualified. A student who receives two grades of “NC” in any APPE course will be disqualified. A student who receives “NC” on the second attempt of a repeated IPPE or APPE course will be disqualified. Disqualification will occur regardless of a student’s cumulative grade point average.

## *C. REMEDIATION POLICY*

### **Purpose:**

USC Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences is committed to students' success in their academic performance. Faculty and staff understand that there are special circumstances that could potentially affect a student's ability to achieve desired outcomes. This remediation policy is created to help guide students who are committed to their own success of learning but either were affected by unforeseen circumstances (e.g. death in the family, emergent illness, mental health) or may underperform even after exhausting all available extra help with a course (including responding to outreach from course instructors, student affairs, participated in peer tutoring, etc.). This policy applies to all required didactic curriculum courses, whether on-ground or virtual/remote teaching. There is no remediation for elective courses. A remediation process for experiential courses is addressed in the Reconciliation of Grades section of the Student Handbook.

### **Procedure:**

#### *Eligibility:*

Students who are eligible to enter the remediation process should meet all the following criteria:

- Not on academic or academic integrity probation and received a "NC", or "IX" or a letter grade below "C" for required course(s) at the end of the semester.
- Has never entered remediation for the same course.
- Has not completed remediation for more than two courses throughout the first three years of pharmacy school.

Students who missed an exam for required course(s) are NOT eligible for remediation. These students can arrange a make-up exam with the course coordinator(s).

#### *Process to enter remediation:*

1. The Course Coordinator(s) will identify the student who has earned a failing grade and will notify the Director of Student Success and Engagement (DSSE). The DSSE will notify the Scholarship Standards Committee (SSC), Course Coordinator(s), Wellness Counselor (WC), and the student to set up a meeting to discuss remediation. The meeting must be scheduled before the start of the following semester and will also be attended by the Senior Associate Dean of Academic and Student Affairs and the DSSE to serve in administrative roles.
2. The Wellness Counselor will meet with the student to draft a letter reflecting on why the student needs remediation. The DSSE should receive the letter to share with the SSC no later than 3 days before the scheduled meeting.
3. At least 3 days before the scheduled meeting, the Course Coordinator(s) will send the DSSE a report of how the student earned a failed grade (e.g., low score on exams, missed Blackboard assignments) to share with the SSC and WC.
4. During the meeting with the Course Coordinator(s) and the student, the SSC will ask the student and Course Coordinator(s) questions to understand what the student needs to demonstrate competency in the course. Once all questions are answered, the student will be asked to leave the meeting. The SSC and Course Coordinator(s) will then discuss a remediation agreement (e.g., day/time of assessment(s), method of assessment(s), and passing score).

5. Remediation will be scheduled during winter break or during the summer at the discretion of the course coordinators.

6. The WC will send an official remediation agreement to the student signed by both the SSC Chair and Course Coordinator(s). The student completes the appropriate sections, signs the agreement, and returns a copy to the WC, the Course Coordinator(s), the DSSE, and the SSC Chair within 3 days of receiving the agreement. This indicates that the student is committed to the process written in the agreement. If the student has questions or concerns about the remediation agreement, they must notify the WC within 3 days of receiving the letter.

7. After the remediation process is complete, the Course Coordinator(s) must indicate the outcome of the remediation process on the remediation agreement, then send the copy to the SCC Chair, WC, and the DSSE. If the course is following a letter grade system, the student's letter grade will be no higher than a 'C' or "CR" for Credit/No Credit courses.

- A. If the student completes the remediation process, the DSSE will submit a grade change. The student will progress to the following semester.
- B. If the student does not complete the remediation process, the student's original grade remains unchanged, and the student will need to follow the "reconciliation of grades" and "delay in progress" policies outlined by the Student Handbook. The student must contact the DSSE to discuss the changes in their curriculum plan.

**Remediation period:**

Remediation of a single course should be completed before progressing in the curriculum. The entire remediation process must be completed before the start of the following academic year. The Course Coordinator(s) determine the timing of remediation depending on the material to be remediated. For example, if the course was taken in the fall, it may be completed before the start of the following spring semester, but all courses must be completed before the start of the following fall semester.

**Maximum allowable remediation:**

Students can enter remediation for at most two courses during the first three years of pharmacy school, prior to the first APPE rotation. Students cannot enter remediation for the same course.

If the student requires remediation two consecutive times within the same academic year, two consecutive times within the calendar year, or two different courses within the same semester, the student will be placed on academic probation for the following semester regardless of the student's cumulative GPA. If the student exceeds the maximum number of remediations by Fall semester of P3 year, the student will not be granted another remediation but will need to follow the "reconciliation of grades" policy outlined by the Student Handbook and be placed on a "Delay in Progression" status.

#### *D. PROGRESSION TO SUCCEEDING ACADEMIC YEAR*

1. A student is required to meet Satisfactory Academic Progress (SAP) to be permitted to advance from each year. Satisfactory Academic Progress (SAP) is defined as earning a minimum of 2.50 GPA and minimum grade of “C” or “CR” for all courses for all students in the Doctor of Pharmacy.
  - Failure to meet SAP requirements may have implications to student’s financial aid. All related SAP/Financial aid questions should be addressed with the financial aid office at [pharmfao@usc.edu](mailto:pharmfao@usc.edu).
  - All terms and cumulative grade point averages will be reviewed by the Senior Associate Dean for Academic and Student Affairs at the end of each semester. Students who do not meet the minimum academic requirements will receive a written notification and be placed on academic probation for the following semester.

Students who are in a “delayed in progress” status must meet with the Director of Student Success and Engagement to discuss changes in their program plans. Students must also connect with the Wellness Counselor to create a plan on how to meet SAP requirements. Both meetings must occur before the start of the following semester.

#### *E. CURRICULUM & GRADUATION REQUIREMENTS*

The PharmD degree combines rigorous basic & clinical science education with extensive and varied practice experiences so that students will be prepared to contribute to revolutionizing the future of health care through new discoveries and innovations to improve patient lives.

PharmD students are required to complete the four-year curriculum and earn a minimum of 1,740 hours of practice experience. All courses must be successfully completed with a grade of “C” or better in letter graded courses and a grade of “B” quality or better in non-letter graded courses. A minimum cumulative grade point average of 2.50 is also required. Below is additional information on PharmD curriculum:

##### **1. Program Requirements:**

- Continually meet Technical Standards
- Maintain licensure as an Intern Pharmacist: Students must obtain their intern licensure with the California State Board of Pharmacy at the beginning of their first year. The Intern Pharmacist’s license must be active (clear) at all times during enrollment in the PharmD program. Students with an active (clear) Intern Pharmacist license may perform any of the duties of a registered pharmacist while working under the direct supervision of a registered pharmacist.
- Maintain Basic Life Support Certification from the American Heart Association
- Demonstrate competency on P1 through P3 end of year Pre-APPE Objective Structured Clinical Exams (OSCE). If a student is unable to meet the competency, students may need to retake or remediate the OSCE or associated coursework before moving forward in the curriculum.
- Participate in required Interprofessional Education (IPE) events for the P1 through P3 years. If a student misses a required IPE event, the student will need to make-up the missed IPE event at the purview of the director of IPE.

- Years 3-4:
  - Six Advanced Pharmacy Practice Experiences (APPEs)
  - Doctor of Pharmacy Capstones (PHRD 796a and PHRD 796b)

## 3. Co-Curriculum Requirements

The University of Southern California's PharmD program recognizes the importance of co-curricular activities in shaping the student experience and complementing the curriculum. These co-curricular activities advance learning and provide opportunities to apply curriculum knowledge to practical, real-world issues.

- a. **Students will work with PharmD co-curricular office, student organizations, and affinity groups to complete at least 5 co-curricular activities per year.** Students actively engaged for at least one year in a student organization, affinity group, holding student ambassador membership, holding mentor/mentee membership may use those experiences to satisfy one co-curricular activity requirement during the program's entirety. Students admitted to an Area of Concentration (AoC) must complete the five co-curricular requirements specific to the AoC co-curriculum requirements. To comply with program requirements, students must complete a post-activity summary administered through [EngageSC](#) within 36 hours after each co-curricular activity. Failure to complete the post-activity summary within the allocated time will result in the activity not being counted toward the co-curriculum requirements.
- b. **By the end of the spring semester of each year, students must complete the co-curricular end-of-the-year self-reflection.** Self-reflection questions will be provided to students by the co-curricular office in advance. Self-reflections alongside the co-curricular survey will be open for submission starting on the last day of instruction in the spring semester of each academic year. The end-of-the-year co-curricular self-reflection will close five business days after the finals of the said semester. The dates and deadlines for the end of the year co-curricular self-reflection will be provided at the start of each spring semester.

Students may use the co-curricular pathway plan designed by the co-curricular office to comply with program requirements. The co-curricular pathway plan may vary by semester and year to coincide with the curriculum and align with the eight Trojan Pharmacist Outcomes (TPOs). The pathway plan will provide students with a menu of activities that may satisfy each pathway requirement. The pathway plan supplied by the PharmD co-curricular office is designed to assist students in completing their co-curricular requirements. However, the pathway plan is merely a suggested list of activities, not an absolute list for completing the co-curricular

requirement. Students who wish to customize their co-curricular activities may contact the co-curricular office to map a custom activity plan for the semester.

Please note that active student engagement in co-curricular activities is part of the PharmD program requirement. Failure to comply with requirements within the allocated timeframe will result in disenrollment from courses in the subsequent semester and delay the student's progression in the program.

#### **4. PharmD Professional Experience Programs:**

- Introductory Pharmacy Practice Experiences (IPPEs)  
Years 1-3 - Students complete a minimum of 304 hours (Gold curriculum) 360 (Cardinal curriculum) of experiential learning in community, institutional and elective pharmacy practice. There will also be classroom instructions that have been designed to complement and enhance the experiences gained at the various practice sites.
- Advanced Pharmacy Practice Experiences (APPEs)  
Years 3-4 - Students complete six advanced pharmacy practice experiences (APPEs) spread across their final year. APPE blocks are for six-weeks and are offered beginning in the last half of the year 3 spring semester, twice in the summer, three times in the fall, and two times in the final spring semester. Students are assigned to complete six of the eight blocks offered, including either block 7 or 8.

#### *F. ADDITIONAL CERTIFICATIONS*

##### **Areas of Concentration:**

There are seven [Areas of Concentration](#) (AoC) available to PharmD students who may be interested. Students must complete required didactic elective units, experiential units, and co-curricular activities relevant to their chosen Areas of Concentration. All students who plan to pursue an area of concentration must have completed their first year in the PharmD program, have a minimum cumulative GPA of 3.0 in their PHRD coursework, and formally apply. After admission to an AoC, students must maintain a cumulative 3.0 GPA in all PHRD coursework to be considered in good academic standing.

## Section V. VOLUNTARY WITHDRAWAL

Occasionally, it becomes necessary for a student to interrupt or discontinue her/his pharmacy education for nonacademic reasons. All withdrawals must be made by the student according to USC Mann's policy and BEFORE the university's last day to drop a class without a mark of "W" for the subsequent registered term.

### A. *GUIDELINES FOR UNIVERSITY WITHDRAWING FOR P1, P2, P3, AND P4*

A student must submit a request for withdrawal in writing to Student Affairs no later than the tenth week of the semester.

### B. *TIMELINE FOR UNIVERSITY WITHDRAWING FOR P1, P2, AND P3*

If a student officially withdraws from the university prior to the end of the twelfth week of the semester, the student will receive a mark of "W" for all courses in which the student is registered.

### C. *TIMELINE FOR APPE COURSE WITHDRAWING/CHANGING*

If a student officially withdraws/changes an APPE course after the first week and prior to the end of the fourth week of the six-week APPE course, the student will receive mark of "W" in the course(s).

## Section VI. LEAVE OF ABSENCE, WITHDRAWAL AND RE-ADMISSION POLICY

A student entering the Doctor of Pharmacy program is expected to successfully complete all course requirements for the degree within a 4-year period. Under certain circumstances, a student may be permitted an extension to complete requirements for the degree not exceeding 6 years from the date of initial admission.

The California Board of Pharmacy regulations require students to be currently enrolled in a school of pharmacy program in order to maintain a valid Intern License. Student Affairs will notify the CA Board of Pharmacy when a student is no longer enrolled in the USC Mann PharmD program. Therefore, all students must re-apply to the California Board of Pharmacy for a new Intern License upon re-admission to USC Mann.

### A: *LEAVE OF ABSENCE*

#### 1. General Leave of Absence

- A general leave of absence may be granted to a student in good academic standing (e.g., above 2.50 GPA) for a period of one year. A student must submit a request for a leave of absence in writing to Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)) no later than two weeks prior to the start of the semester.
- The student will be notified of approval or non-approval of the request within fourteen days of receipt by Student Affairs. If approved, the student is responsible for completing necessary course registration changes, if any, by the add/drop deadline of the semester.
- A student wishing to extend their general leave of absence for another year must contact the Student Affairs at least one month prior to their expected return and request a meeting with the DSSE to discuss their request. The student will be notified of the approval or non-approval

of the extension within seven days after meeting with the DSSE. Leave of absence cannot be exceeded for more than two years.

## 2. Health Leave of Absence

USC recognizes that there are times when student health needs to be first priority. The health leave process is designed to help students step away from school, focus on their health needs, and return better able to navigate the rigors of their degree. A student's health leave is facilitated by one of the University's Health Leave Coordinators. Health Leave Coordinators assist the student with identifying and implementing a plan for the health leave (in consultation with the academic unit, treatment providers, and relevant campus partners) and also facilitate the student's return when they are well enough to resume their program. Students wishing to go on a health leave should contact Student Affairs ([pharmdsa@usc.edu](mailto:pharmdsa@usc.edu)) to help facilitate the process. ### *B: RE-ADMISSION POLICY FOR VOLUNTARY WITHDRAWAL*

Voluntary withdrawal is defined by a student not registering for their courses in the fall and spring semesters (i.e., breaking continuous enrollment) without prior approval for a leave of absence. A student who has voluntarily withdrawn must submit a written request to the Scholarship Standards Committee to re-enter the pharmacy program no later than a year of their last semester of enrollment. Students who break continuous enrollment for more than a year will be required to reapply. For more information, contact PharmD Student Affairs at [pharmdsa@usc.edu](mailto:pharmdsa@usc.edu).

## **Section VII. ACADEMIC WARNING AND DISQUALIFICATIONS**

Factors other than satisfactory grades and adequate GPAs are considered in determining a student's qualifications for an advanced degree. A student's overall academic performance, specific skills and aptitudes, and faculty evaluations will be considered in departmental decisions regarding a student's continuation in the Doctor of Pharmacy degree program.

### *A. ACADEMIC WARNING-PROBATION*

Satisfactory progress toward an advanced degree as determined by the faculty is required at all times. Students who fail to make satisfactory progress will be informed by the Scholarship Standards Committee or the Senior Associate Dean for Academic and Student Affairs. The faculty has the right to recommend at any time after written warning that a student be dismissed from a graduate program for academic or student conduct reasons or that a student be denied re-admission. A cumulative grade point average of 2.5 are required at all times. Students whose cumulative grade point average fall below 2.5 at the end of each semester will be given a written warning notification that their term and/or cumulative grade point average is insufficient and will be placed on academic probation. All students on academic probation must raise their cumulative grade point average by the end of the following semester to meet their academic progression requirements to advance to the next semester of the program. All students must have a 2.5 cumulative grade point average for graduation. Students whose term grade point average fall below 2.5 at the end of each semester will be given a warning to improve their academic progress for the following semester in order to maintain a minimum of 2.5 cumulative grade point average.

## *B. ACADEMIC DISQUALIFICATION*

A student is subject to disqualification from USC Mann Doctor of Pharmacy program for the following reasons:

1. Grade Point Average Deficiency
  - a. A P1, P2, or P3 student whose cumulative grade point average falls below 2.50 for two consecutive semesters will be disqualified.
  - b. A student who does not meet the terms of their probation will be disqualified at the end of the semester.
2. Number of non-passing Grades
  - a. A student in any year who receives two grades of “C-” or below, two “NC”, or combination thereof of non-passing grades during the program will be disqualified. Disqualification will occur regardless of a student’s cumulative grade point average and will apply after the fall or spring semester.
  - b. A student in any year who receives a grade of “C-” or below or “NC” on the second attempt at taking a course will be disqualified. Disqualification will occur regardless of a student’s cumulative grade point average and will apply after the fall or spring semester

## **PART B. THE STUDENT HONOR SYSTEM**

### **Section I. THE HONOR CODE**

#### **USC MANN SCHOOL OF PHARMACY & PHARMACEUTICAL SCIENCES ACADEMIC AFFAIRS**

##### **PREFACE**

Pharmacy is regarded one of the most trusted profession in the United States (Gallup Poll, 2025). We have earned this top ranking by not only providing quality care to our patients, but by upholding the highest ethical and moral standards. It is our intention to maintain and further this reputation by instituting an Honor System which will foster the development of a culture that makes dishonorable conduct unacceptable.

The Honor System is designed to provide a standard of character, behavior, and performance that promotes a spirit of community conducive to mutual trust among students, faculty, staff, health care professionals and patients. It is designed to be compatible with and not to compromise in any way the University's Student Conduct Code & Review Systems and the American Pharmaceutical Association's (APhA) Code of Ethics. The USC Doctor of Pharmacy program follows the USC Mann Doctor of Pharmacy Conduct Policy and the USC Graduate Academic Integrity policy to uphold the Honor code.

In the event that a conduct or academic integrity violation intersects with sexual, interpersonal, or protected class misconduct, student behavioral misconduct, or sponsored research misconduct, please contact the respective office above to determine how best to proceed.

Attendance or participation as a student, faculty member, administrator, or staff member at USC Mann constitutes acceptance of this Honor System and its procedures. Anyone who cannot or does not pledge to abide by the Honor System is not welcome at the USC Mann.

##### **THE HONOR CODE**

The students, faculty, and administration of USC Mann, in accordance with the high demand for ethical professionalism in which the practice of pharmacy necessitates, do hereby support and consent to the establishment of and adherence to the following Honor Code:

The profession of pharmacy demands excellence of its constituents -- excellence in character, behavior, and performance. Personal integrity, intellectual honesty, and ethical conduct are the principles that we hope to exhibit in these three categories both while enrolled at the USC Mann and as practicing professionals.



### *Excellence in Character*

The foundation of “the most trusted profession” clearly rests in the moral character of the individuals employed in it. Personal strength, marked by integrity, honesty and ethics, is the cornerstone in which pharmacy professionals have abided in order to obtain their reputation. In preparation for this position, students at USC Mann should endeavor to respect the moral standards required by their future profession and act accordingly. Excellence in character is the building block for the future of the profession of pharmacy.

Personal integrity, intellectual honesty and ethical conduct are the cornerstones of the profession for which students at USC Mann prepare. The foundation of this attitude is exemplified by a philosophy to be thoughtful, honest and sincere. It is therefore important that the student shows personal respect, as well as respect for peers and future patients by exhibiting these principles while in school to attain the highest standards set by our profession.

### *Excellence in Behavior*

USC Mann is a community of students and professionals concerned with upholding higher standards of conduct. Therefore, the preservation of the Honor Code principles is the responsibility of all members of USC Mann’s academic community.

Students accept their obligation to a self-imposed discipline, individually striving to maintain their personal and academic environments in a manner that reflects the principles of the Code. In addition to being of moral character, students pledge to behave in accordance with the provisions of the Code. It is their promise to never act in any fraudulent manner, either academically, personally, or professionally, and to maintain the confidentiality of individuals who accuse others and who are accused of violations of the Honor Code. Lastly, students assume the significant responsibility of protecting the Honor Code’s integrity. Each student, by virtue of his/her enrollment at USC Mann, not only must abide by the Honor Code System, but must also agree to enforce its principles, including the reporting of violations of the Honor Code.

Faculty have an important role in the preservation of the Honor Code. Not only is it their responsibility to encourage the principles governing the Code, but it is their obligation to facilitate an academic atmosphere that purposely discourages any type of academic fraudulent activity. Furthermore, faculty members must dutifully and consistently report all Honor Code violations they may witness or suspect in order to preserve and uphold the integrity of the Code, its purpose, and its standards.

### *Excellence in Performance*

The honor of the profession of pharmacy is that we, as pharmacists, help others with our expertise. Just how well we benefit patients depends enormously on our own professional performance. Therefore, as students, we must not create any incorrect impressions of our abilities, nor must we attempt to take any unfair advantage of our colleagues in the academic setting. To do so would violate the excellence demanded and expected of us, as pharmacists, by society. Most important, falsifying our abilities can be potentially harmful to patients we may encounter in the future.

The Honor Code demands that no student, faculty, or staff member act to create an incorrect impression of one’s abilities. As a student and professional, it is not wrong to admit that one does not know an answer to a question. Rather, it is wrong to give falsified information instead of finding the correct answer.

USC Mann follows the Reporting of violations is an integral part of this Honor System. Unreported dishonest activity thwarts learning, accurate performance evaluation, and negates the otherwise trustworthy image of professional graduates as competent and knowledgeable. Confidentiality for individuals accused of violation and the name of the accuser must be held in confidence at all times, or until such time as a Review Panel finds that the evidence merits a Formal Hearing. Any party who does not contribute to enforcing the Honor Code, is still in violation of these principles.

## **Section II. THE CONDUCT GUIDANCE**

### ***A. USC CONDUCT GUIDELINES:***

USC Conduct Guidelines describe the high standards of *character*, *behavior*, and *performance* expected of PharmD students in all academic, professional, and administrative settings.

#### ***Character:***

- *Respect* – Shows respect and courtesy to students, faculty, staff, peers, patients, and other health professionals;
- *Integrity* – Exhibits honesty and strong moral values
- *Cultural Awareness* – Respects all faculty members, staff, and fellow students regardless of, race, gender, religion, sexual orientation, age, disability or socioeconomic status; Demonstrates sensitivity toward others with choice of language, tone, and actions

#### ***Behavior:***

- *Punctuality* - Arrives on time and prepared for required classes, labs, and rotation hours; Notifies instructors, course coordinators, preceptors, or administration in advance, or at earliest possible time, regarding absence or tardiness; shows responsibility for maintaining information regarding assignments and responsibilities and keeps up to date with deadlines; shows responsibility in completing degree requirements in a timely manner, including course registrations, financial aid, and IPPE or APPE clearance requirements.
- *Professional Attire* –Maintains good personal hygiene, a neat and clean appearance, and dresses in attire that is accepted as professional in all academic and clinical settings. Refer to the “Dress Code” section in the Student Handbook for additional information
- *Communications* – Truthful in communication to others; Admits errors and does not mislead others or promote oneself at the expense of others; Demonstrates responsibility in checking emails and other forms of communication on a regular basis

#### ***Performance:***

- *Service and Care* – Demonstrates respect, empathy, and concern for the welfare of colleagues and patients; Maintains confidentiality of student and patient information
- *Knowledge* – Strives to gain knowledge and best professional judgment; Demonstrates preparedness to interact in classroom, laboratory, and clinical settings; Ask appropriate questions and stays engaged
- *Professional Development* – Demonstrates good organizational and interpersonal skills; Shows willingness to admit mistakes, recognizes areas of growth in knowledge and/or practice skills, and responds well to constructive criticism to improve quality of work and learning

### ***B: VIOLATIONS OF THE CONDUCT POLICY INCLUDE BUT NOT LIMITED TO:***

- Any unreasonable or reckless conduct by a student that is inherently or potentially unsafe to other persons (e.g., peers, patients) or organization (e.g., school, hospital, clinic).
- Any act or conduct in a manner that impedes, interferes with, or disrupts any university teaching, research, rotation hours, co-curricular activities, or other authorized activity, including not registering for required courses on time (missed add/drop deadlines), not completing clearance requirements, and other rotation requirements for IPPE or APPE.
- Not performing to the high standards expected of PharmD students (e.g., consistently arrives late to scheduled rotation hours, not prepared for responsibilities, not receptive to feedback, does not adhere to required professional attire).
- Sending excessive email communications to faculty, students, or administration (e.g., multiple emails in less than 24 hours or outside business hours), or not responding to email communications within 24-72 hours of email receipt.
- Misusing or misrepresenting one's status as a pharmacy student or the right to use any university property/healthcare and facilities.
- *Any* condition or behavior which may endanger clients, patients, or the public, including failure to carry out the appropriate or assigned duties.
- Failure to comply with directions of university officials or clinical supervisors acting in the performance of their duties as students, student pharmacists or organization leaders.
- Hazing or any actions that may produce mental or physical discomfort, embarrassment or harassment towards another person.
- Stealing, damaging, defacing, or unauthorized use of any property of the school or university or health care setting.
- Any action or behavior that would be considered unprofessional conduct or inappropriate for members of an academic institution.

### *C. FILING A REPORT:*

Faculty or administration who have a concern about a student's behavior should make an attempt to first give the student corrective counseling and feedback immediately after the issue has occurred (i.e., first verbal or written warning). If the behavior is egregious or persists after feedback is given, the Director of Student Success and Engagement (DSSE) should be notified within two weeks of the second incident, to submit a Report to the Office of Community Expectations (OCE). <https://communityexpectations.usc.edu/>

### *D. REVIEW OPTIONS:*

1. Generally, incidents will either be reviewed via an informal review process or formal review process within the Office of Community Expectations.
2. Informal Review
  - a. The student discusses the incident, and potentially comes to an agreement as to responsibility and sanction (if any).
  - b. The Individual Review may take place over the course of multiple meetings.
  - c. No other parties are permitted to participate in or observe the process.
  - d. The student has the right at any time prior to an Informal Review decision to opt out and pursue a Formal Review.
3. Panel Review

- a. There are two avenues for formal resolution of an allegation of non-academic misconduct: an **Administrative Review** and a **Review Panel**.
- b. In an Administrative Review, the student will be invited to meet with OCE staff to discuss the incident, answer questions, and provide their perspective of what occurred.
- c. If it is determined that there exists insufficient information to conclude that the student violated university policy by a preponderance of the evidence (i.e., what is more likely to have occurred) standard, then the case will be dismissed with no findings or outcomes issued.
- d. If the student accepts responsibility for the allegations, OCE staff may seek to reach an agreement with the student during the administrative review as to appropriate outcomes. If an agreement is reached (i.e., the student accepts responsibility for the alleged violations and the outcomes proposed by OCE staff), the matter is considered resolved and no appeal is available.
- e. If the student challenges either the findings of responsibility and/or the outcomes proposed by OCE staff, the next steps are dependent on the possible outcomes proposed by OCE staff.
- f. If an outcome could include suspension, expulsion, revocation of admission, or revocation of degree, OCE staff will refer the matter to a **Review Panel** for its determination of responsibility and outcomes. The student's previous disciplinary record will be considered in determining appropriate outcomes and the student retains their ability to appeal the decision issued.
- g. If there is no potential outcome of suspension, expulsion, revocation of admission, or revocation of degree, OCE staff will use a preponderance of evidence standard to determine if the student is responsible for the allegation(s). (There is no option for a review panel.) If so, OCE staff will determine the appropriate outcomes with consideration of the student's previous disciplinary record (if any). The student may submit an appeal.

#### *F: APPEAL PROCESS:*

Appeals are permitted by the student on one or more of the following grounds:

1. New information that is sufficient to alter the determination of responsibility, and which the student was not aware of or could not have reasonably obtained at the time of the initial review.
2. Procedural error(s) that materially impacted the determination of responsibility. (Procedural or technical irregularities will not be sufficient to sustain an appeal unless found to have affected the determination of responsibility.)
3. The outcome(s) assigned is (are) disproportionate to the determination of responsibility.

The Vice President for Student Life or designee will consider the written appeal and information/documents considered in the review and provide a written decision to the student and OCE. The Vice President for Student Life or designee may uphold the initial decision in its entirety, send the case back to OCE for further review, reverse a finding of responsibility, modify the outcome(s), or dismiss the case. This decision is final and binding and there is no further avenue for appeal.

### **Section III. USC ACADEMIC INTEGRITY**

1. Preface (from the University of Southern California Graduate Academic Integrity Policy)

USC's Unifying Value of integrity is a foundational principle that inspires the community to match its values to its actions. Academic integrity is ultimately the sole guarantor of the legitimacy of one's education, and therefore, is vitally important not just for oneself, but for the entire USC community. The value of all USC degrees is negatively impacted by violations of academic integrity.

In the classroom, general principles of academic integrity include the concept of respect for the intellectual property of others, the expectation that individual work will be submitted unless otherwise allowed by an instructor, and the obligations both to protect one's own academic work from misuse by others as well as to avoid using another's work as one's own. All students are expected to understand and abide by these principles. Instructors may include additional classroom and assignment policies, as articulated on their syllabus.

2. Academic Integrity violations (academic dishonesty) include, but are not limited to:

### *Plagiarism*

- The submission of material authored by another but represented as the student's own work, whether that material is paraphrased or copied in verbatim or near-verbatim form.
- Re-using any portion of one's own work (essay, term paper, project, or other assignment) previously submitted without citation of such and without permission of the instructor(s) involved.
- Improper acknowledgment of sources in essays or papers, including drafts. Also, all students involved in collaborative work (as permitted by the instructor) are expected to proofread the work and are responsible for all particulars of the final draft.
- Acquisition of academic work, such as term papers, solutions, or other assignments, from any source and the subsequent presentation of those materials as the student's own work, or providing academic work, such as term papers, solutions, or assignments submitted by another student as their own work.

### *Cheating*

- Submitting material that was substantively drafted or revised by another.
- Any use or attempted use of external assistance in the completion of an academic assignment and/or during an examination; or, any behavior that defeats the intent of an examination or other classwork or assignment, unless expressly permitted by the instructor. Examples of unacceptable behaviors include communicating with fellow students during an exam period; soliciting or providing information about an exam during an exam period; accessing online resources or learning platforms during an exam; copying or attempting to copy material from another student's exam; allowing another student to copy from an exam or assignment; possessing or using unauthorized notes, materials, calculator, cell phone/other device during exams; and/or, removing or sharing without authorization exam materials.
- Submission of work altered after grading shall be considered academically dishonest, including but not limited to changing answers after an exam or assignment has been returned or submitting another's exam as one's own to dispute a grade and/or gain credit.
- Obtaining for oneself or distributing any academic work, such as solutions to homework, a project or other assignment, or a copy of an exam or exam key, without the knowledge and expressed consent of the instructor.
- Unauthorized collaboration on any academic work, such as an exam, a project, homework, or other assignment. Collaboration will be considered unauthorized unless expressly part of the assignment in question or expressly permitted by the instructor.

- Taking a course or completing any coursework or exam for another student, or allowing another individual to take a course, complete coursework or a portion of a course, or exam in one's stead.
- Accessing, altering, and/or using unauthorized information.

#### *Other Violations of Academic Integrity*

- Fabrication: Submitting material for lab assignments, class projects, or other assignments which is wholly or partially falsified, invented, or otherwise does not represent work accomplished or undertaken by the student.
- Distribution or use of notes, recordings, exams, or other intellectual property, based on university classes or lectures without the express permission of the instructor for purposes other than individual or group study is prohibited. This includes but is not limited to providing materials for distribution by services publishing course materials. This restriction on unauthorized use also applies to any information created by another, distributed to students, or displayed for use in relation to the class, whether obtained in class, via email, on the internet, or via any other method. Distributing course material without the instructor's permission will be presumed to be an intentional act to facilitate or enable academic dishonesty and is strictly prohibited.
- Recording a university class without the express permission of the instructor and announcement to the class, or unless conducted pursuant to an OSAS accommodation. Recording can inhibit free discussion in the future and, thus, infringe on the academic freedom of other students as well as the instructor.
- Failure to comply with protocols, policies, procedures, or instructions as it applies to exams or other academic work.
- Falsification, alteration, or misrepresentation of official or unofficial records or documents including but not limited to academic transcripts, résumés, academic documentation, letters of recommendation, admissions applications, or related documents.
- Any act that gains or is intended to gain an unfair academic advantage may be considered a violation of academic integrity.
- Furnishing false information to any university official, faculty member, or office. This includes but is not limited to furnishing false information in academic petitions or requests, financial aid documents, student employment documents, applications, financial statements or other documents, or intentionally evading university officials and/or obligations to the university. Students are responsible for verifying the accuracy of any information submitted to the university by any third party on their behalf.
- Any attempt to hinder the academic work of another student or any act which may jeopardize another student's academic standing, including but not limited to tearing pages out of a library book, tampering with or removing another student's academic work (either physically or electronically), or manipulating electronic systems to gain an advantage in class registration or other academic status.

### 3. Sanctions

- A. Sanctions for academic integrity violations are based on the general principle of equal and fair treatment and take into account the student's remedial needs and prospects for improvement. The goal of the resolution process, particularly for first time offenses, is to educate rather than punish. At all times during this process, it is important to recognize the pedagogical opportunity this process provides.

- B. Sanctions are designed to hold students accountable for both their conduct and resulting consequences. Failure to comply with the terms of imposed sanctions should lead to further and more severe disciplinary action. Sanctions for second offenses should be more severe.
- C. One or more of the following sanctions may be imposed for a student found responsible for an academic integrity violation:
  - 1. Revocation of Degree. The student loses the right to claim the degree as earned. Posting of the degree will be removed from the student's transcript, and a permanent notation will be made on the transcript indicating the revocation, the degree involved and the date of the action.
  - 2. Expulsion: Permanent termination of the student's right to enroll or participate in any classes, seminars, laboratories and clinical programs, at any School, at the University of Southern California. A Panel Review is required in order to impose a sanction of expulsion.
  - 3. Suspension: Termination of a student's right to participate in any classes, seminars, laboratories and/or clinical programs, at any School at the University of Southern California, for a specified period of time. After suspension, the student's status may be probationary for the remainder of their time at the School. A Panel Review is required in order to impose a sanction of suspension.
  - 4. Dismissal from an Academic Unit: Permanent termination of the student's right to enroll or participate in the classes, seminars and/or programs of a specific academic unit, school or department.
  - 5. Removal from an individual course or section of a course. Removal precludes the student from participation in and attendance of the course or section, or any of its sessions. In multiple section courses, the student will not necessarily be allowed to transfer to another section.
  - 6. Grade Sanctions: Grade sanctions are appropriate for any academic violation.
  - 7. Other: Other sanctions may be imposed or deferred at the discretion of the deciding body in addition to those specified above. These include creative sanctions such as special projects designed as learning experiences, as well as denial of privileges such as restriction or denial of participation in specific activities at the School or in activities sponsored by the School.
  - 8. Warning: Written notice to the student that continued or repeated violations may be cause for further disciplinary action, normally in the form of disciplinary probation, suspension or expulsion.

#### 4. Process

##### A. Submission of a report

1. Only faculty members are permitted to report a violation. If a student/other has reason to believe an academic integrity violation has been committed, they should communicate with the instructor/designee of the course.
2. Students/others who wish to communicate their concerns anonymously should be informed that while the academic integrity process is designed to include only those with a need to know, absolute anonymity cannot be guaranteed.
3. Reports may be submitted up to one year after the date of the alleged incident. This timeframe may be extended under special circumstances (for example, the report, if true, would warrant the revocation of a degree).
4. Reports will be received by the [Office of Academic Integrity](#) (OAI), who serves as the centralized Academic Integrity office for all of USC.
5. Because the student may contest the allegation, they must be allowed to attend all classes and complete all assignments until the report is resolved.

#### B. Notice to student

1. The OAI will provide notice to the student, through Advocate, of the exact allegations and subsequent process.
2. The student may not withdraw from a course in which they have been accused of committing an academic integrity violation.
3. If the student is non-responsive, the OAI may:
  - a. Compel the student using communication from higher level of administration.
  - b. Provide a final notice to the student that the decision-making process will proceed without them.
4. If the student has communicated a disability, physical, mental or health issues, or special circumstances, the OA will work with the Office of Student Accessibility Services, Student Counseling Services, or Student Support and Advocacy to determine how best to proceed.

#### C. Review Options

1. Generally, the student will determine whether to pursue an Faculty-Student Resolution or Administrative Review process. However, the following decisions may not be made in an Faculty-Student Resolution and are required to be made by the Panel:
  - a. *Sanctions for a student with prior incident(s)*. The Panel is required to provide a sanction for a student who has been found responsible for previous academic integrity violation(s).



- b. *Elevated sanctions*. The Panel is required to conduct the case review if the initial report recommends a sanction of program dismissal, suspension, expulsion, or revocation of degree.
- 2. Faculty-Student Resolution
  - a. The OAI shall arrange a time for the student and faculty member to discuss the incident together, and potentially come to an agreement as to responsibility and sanction (if any).
  - b. The Faculty-Student Resolution may take place over the course of multiple meetings.
  - c. The student has the right at any time prior to the final Faculty-Student Resolution decision to opt out and pursue a Panel Review.
- 3. Administrative Review Process
  - a. The Office of Academic Integrity shall convene the University's Academic Integrity Panel ("Panel") to discuss with the student and reporter the case file, which includes the report, the student's response, and any supporting documentation.
  - b. The Panel shall be composed of members of USC faculty, staff, and/or students and invite the student and any other involved parties.
  - c. The student is allowed to invite one additional support person to attend the Panel.
  - d. The Panel shall make a determination as to the student's responsibility and sanction, if any.
  - e. The student or faculty member is permitted to appeal the Administrative Review decision within 3 calendar days of the date of notice, unless otherwise permitted to the Vice Provost Stott.
- 4. Final Decision:
  - a. If the final determination finds the student is not responsible, the OAI will provide notice to parties and the Registrar of dismissal of the case.
  - b. If the final determination finds the student is responsible, the OAI will provide notice to the parties and the Registrar.

*Note:* If the final determination is a sanction of program dismissal, suspension, expulsion, or revocation of degree, the OAI will use Advocate to provide an additional notice to the offices below:

- c. Close Out. The OAI will close the incident.

- d. Student found responsible for an academic integrity violation will be placed on academic integrity probation for one semester following the date of the incident. The student must also meet with the Senior Associate Dean for Academic and Student Affairs once a semester until graduation.

#### **Section IV. STUDENT GRIEVANCES and PROCEDURES**

PharmD students who encounter problems relating to the USC Mann Doctor of Pharmacy Program have a variety of avenues open to them to seek resolution. Students are recommended to first attempt a resolution to any problem directly with the person(s) most closely involved. However, in the event that this step does not resolve the issue, then the faculty and staff at USC Mann are available to work with students in this regard. The DSSE is available to assist and advise students at any point during the progressions. Depending upon the nature of the issue, these progressions suggested below can be entered at any level.

##### **General Academic Concerns Related to a Course**

Concerns about assessments of a course (e.g., exam grade, assignments, quizzes) should be taken directly to the course coordinators. For general academic concerns (e.g. course material, teaching style, examination, etc.), students should follow this stepwise progression:

1. Course Instructor(s)
2. Class Board Curriculum Representative and Class President
3. Course Coordinator(s)
4. Associate Dean of Curriculum

##### **For Disputing a Final Grade**

Students who have questions about their final grade are expected to work directly with the Course Coordinators. In the interest of preserving the very important student-instructor relationship, the student and instructor should try to resolve the grade dispute by direct communication. Only failing grades can be appealed beyond the course coordinator using the appeals process to the Scholarly Standards Committee.

##### **Curriculum-Related Concerns**

For issues or suggestions pertaining to the USC Mann PharmD Program curriculum (e.g. overall workload for the semester, number of hours in class, course relevance, integration of courses, course sequencing, curriculum enhancement, etc.), a typical stepwise progression would be as follows:

1. Class Board Curriculum Representative and Class President
2. Course Coordinator(s)
3. Year Coordinator
4. Associate Dean of Curriculum

##### **Conflict Resolution Related to a Faculty Member**

Students who encounter problems with a faculty member should first attempt to resolve the conflict with the person(s) directly. A typical stepwise progress for student-faculty conflict resolution is as follows:

1. Faculty member
2. Year Coordinator
3. Department Chair

### **Student Complaint Regarding Policies, Procedures, and Regulations**

The USC Mann is committed to providing a quality education to all of its students. We aim to provide an effective learning environment and a supportive community for the students. Any complaints regarding the School's policies, procedures, and regulations should first be addressed with Student Affairs. In the event that the office is unable to produce acceptable results, there are other options within and outside of the school for further assistance. A typical stepwise progression is as follows:

1. Director of Student Success and Engagement
2. Senior Associate Dean of Academic and Student Affairs

### **Student Complaint Regarding Harassment, Discrimination, or retaliation on the basis of a protected characteristic, or rights of protected classes**

Any complaints are handled by the Office of Civil Rights Compliance by calling (213) 740-5086. The Office of Civil Rights Compliance will consider and investigate any complaints brought forth by either students, staff, applicants, or faculty. ### **Other Concerns**

Any other concerns not described above are handled by Student Affairs and will be communicated to the appropriate administrator at the School or University. Students desirous of filing a complaint against a University staff member, professor, or department can also receive guidance from the Office of the Vice Provost of Graduate Programs or the Office of the Vice President for Student Affairs, Student Support and Advocacy Office.

### **ACPE Complaints Policy**

Complaints regarding the USC Mann's compliance with [accreditation standards](#) may be directed to the Accreditation Council for Pharmacy Education (ACPE). Please review the [information](#) about submitting complaints, and use this [form](#) to submit a notification to the Accreditation Council for Pharmacy Education (ACPE) regarding your concern that a program is not in compliance with accreditation/certification standards/quality criteria.

## **Appeal Process**

All students and faculty have the right to file an appeal on any decision related to enrollment and/or academic decisions to the Doctor of Pharmacy Program Scholarly Standards Committee.

1. The student and faculty are permitted to appeal within 3 calendar days of the date of notice, unless otherwise permitted. Appeals, along with supported documents, shall be submitted to the Director of Student Success and Engagement (PharmDSA@usc.edu).
2. In most cases, the status of a student will not be altered, and academic warning-probation, disciplinary sanctions, and/or academic disqualification will not be implemented until completion of the appeal.
3. If the student or faculty does not submit an appeal, the decision related to enrollment and/or academic will move forward.
4. Appeals are only permitted on the following grounds, which must be indicated by the student when submitting the appeal:
  - a. New evidence has become available which is sufficient to alter the decision, which could not have been reasonably obtained at the time of the initial review.
  - b. The decision imposed is excessive, insufficient, or inappropriate.
  - c. The school failed to follow university rules pertaining to the review of the student's academic progress.
5. The Director of Student Success and Engagement will share the appeal documents to the Senior Associate Dean of Academic and Student Affairs, who will review and determine if the above grounds for an appeal have been met. If there is grounds for the appeal, the Senior Associate Dean of Academic and Student Affairs will reconvene the Scholarship Standards Committee (SSC) to re-review the case within . The SSC will submit a written final determination of the appeal to the Senior Associate Dean of Academic and Student Affairs and the Director of Student Success and Engagement within seven (7) calendar days of the SSC meeting, unless otherwise permitted. The Associate Dean of Academic and Student Affairs will notify the student of the final decision, which is final and binding.

#### **Scholarship Policy**

USC and the USC Mann School of Pharmacy and Pharmaceutical Sciences award a variety of scholarships each year to new and continuing students based on a variety of factors, including top tier students, high needs, historically marginalized groups, and excellent citizens of USC Mann. New

students seeking scholarships will be reviewed upon acceptance using information obtained during the admission process. There is no other scholarship application for new students. Current students should complete their Scholarship Profile annually each spring, which will be used by the Scholarship Awards Committee to make award recommendations.

## **School Service Opportunities:**

### **School Info Sessions and Tours**

Throughout the year, the School hosts a number of information sessions with school tours for prospective applicants. Student involvement includes being a member of the student panel and acting as a tour guide for those that attend. As a panelist, students are expected to answer questions from prospective applicants and talk about their personal experiences at the school. Students will also lead the prospective applicants on a brief tour around the campus.

### **Student Admissions Committee**

Students can volunteer their time by applying for membership with the Student Admissions Committee (SAC). As a member, students will have the opportunity to meet and interact with USC Pharmacy applicants on their interview dates as well as provide feedback to the School for outstanding applicants. Potential roles as a SAC member include:

1. **Greeter:** Meet the applicants as they arrive and help them settle in by having breakfast/lunch. This period will serve as a brief Q&A between applicants and current students. The greeters will then lead applicants to their designated interview rooms.
2. **Group Session Leader:** Students will meet in a group with faculty and a group of applicants to hold a group discussion, getting to know one another as well as getting to know the School. Students should also be prepared to answer questions from applicants.
3. **Tour Guide:** Lead applicants on a tour of the School. Along the way, students will provide a brief history of the School as well as answer any questions applicants may have.
4. **Student Interviewer:** Students are paired with a faculty or alumni member, and together they will interview the prospective student. This role is typically given to P2, P3, or P4 students; however, exceptional P1 students that have been involved with the admissions process may be given the opportunity to interview.

### **Student Ambassadors of the Margaret and John Biles Leadership Center**

Students that demonstrate exceptional leadership, professionalism, and academic excellence may be recommended to become a Student Ambassador later in the school year. Student Ambassadors are expected to represent the School as a student leader and scholar at a number of events, including outreach efforts to prospective and newly admitted applicants. Ambassadorship terms are expected to last until graduation. A minimum grade point average of 3.0 is required to maintain Ambassadorship.

### **Hazing**

Hazing is a serious violation of university policy and is a fundamental breach of USC's unifying values. The California Penal Code (245.6) defines hazing as:

...any method of initiation or preinitiation into a student organization or student body, whether or not the organization or body is officially recognized by an educational institution, which is likely to cause serious bodily injury to any former, current, or prospective student of any school community college, college, university, or other educational institution in this state. The term hazing does not include customary athletic events or school-sanctioned events.

In addition to California law, the university's policy with respect to hazing prohibits students from engaging collectively or individually in any of the following practices as a part of any programs or general activities. The "choice" to participate in an activity does not make the activity in accordance with these guidelines. In hazing situations, such a "choice" is typically offset by the peer pressure and power dynamics that exist when individuals are seeking to gain membership into an organization. Hazing includes, but is not limited to:

- Forced excessive or strenuous physical activities
- The application of foreign substances to the body
- Forced creation of digital content that would cause ridicule or embarrassment
- Activities such as scavenger hunts, which result in illegal or otherwise prohibited activity, such as pledge ditches, kidnaps, and the like
- Depriving students of sufficient sleep (eight consecutive hours per day minimum), decent and edible meals, means of bodily cleanliness (minimum of one shower per day), or means of communications (such as access to their cell phones)
- Forcing, coercing, or permitting students to eat or drink an excess of any substance
- Forcing students into remote digital environments, such as Zoom rooms
- Forcing, coercing, or permitting students to undress, or dress in a degrading manner
- Branding, tattooing, or burning any part of the body

- Psychological hazing, which is defined as any act or peer pressure which is likely to compromise the dignity of any student affiliated with the organization; cause embarrassment or shame to any student affiliated with the organization; cause any student affiliated with the organization to be the object of malicious amusement or ridicule; and/or, cause psychological harm or emotional strain

All students and RSOs will observe and fully comply with California law and university policy against hazing. In addition, all students and RSOs are expected to adhere to related regulations set forth by their respective inter/national, regional or local organizations and university department(s). It is the responsibility of students and officers of organizations to be informed of all the regulations and to ensure they are brought to the attention of the rest of the membership.

Anyone with information about a possible hazing incident has a responsibility to report it to the Department of Public Safety (213-740-6000, or [dps.usc.edu](http://dps.usc.edu)). Additional opportunities for reporting hazing include:

## SECTION IV. STUDENT WELLNESS

Pursuing a doctorate degree is an exciting yet challenging time for many students. For some, the transition to the PharmD program at USC can be a significantly difficult adjustment following an undergraduate academic career. PharmD students are expected to juggle a variety of difficult tasks, including navigating a rigorous didactic curriculum and demonstrating competency in pharmacy practice experiences, all while managing personal lives and attempting to achieve balanced and healthy lifestyles. In addition to these stressors, many students are also heavily involved in co-curricular activities such as serving in leadership positions with professional organizations, volunteering in the community, and working and participating in legislative advocacy. Furthermore, the majority of students who pursue internships often have the extreme burden of managing reduced studying time, which is especially straining during midterm and final exams.

While juggling these activities and stressors, it is not uncommon for students' wellness efforts to suffer. Healthy eating, hydration, adequate sleep, exercise, personal time, and family time often become progressively lower priorities compared to other demands associated with pharmacy school.

At USC Mann, the overall well-being of our students is a priority, and concepts in wellness are emphasized throughout the PharmD program. However, students must exercise a level of self-awareness and commitment regarding their own wellness, and work to maintain personal wellness as a priority. Here are some helpful tips to actively pursue wellness:

- Schedule personal time and study time just as you would schedule class or work
- Commit to getting at least 7 hours of sleep each night
- Drink plenty of water to stay hydrated
- Get moving! Consider the use of a fitness tracker to monitor daily activity and sleep.
- Maintain a diet low in saturated fat and sodium
- Stay active in activities outside of pharmacy school, such as hobbies, social time, etc.

To support and promote well-being and community-building, USC Mann has created an initiative called Project Wellness. Project Wellness aims to provide novel and necessary programs for all students, staff, faculty, and our greater community. To further promote wellness and community-building on the USC Health Sciences Campus, Project Wellness often collaborates and promotes other campus wellness groups' programs. All programs are free and everyone is encouraged to participate. Project Wellness is always receptive to new ideas for programs and seminars in order to better cater to the needs of our community. ## Section V. PROFESSIONAL CONFERENCES ATTENDANCE POLICY

### Background

PharmD candidates of USC Mann are encouraged to attend professional conferences throughout the academia year. Faculty are encouraged to support student attendance to professional conferences to facilitate leadership, professional development, and representation of USC Mann. This policy represents the minimum standard that courses can honor. Faculty may find additional ways to accommodate the student and outline such requirements in the course syllabus.

### Process

1. Check with the ASP VP of Professional Conferences if the conference you are interested in is an approved professional conference/meeting.
2. Only students in good academic standing may officially represent the University at Approved Professional Conferences/Meetings. Good academic standing will be defined as a current **GPA of 2.5 or higher**. *Note to the student:* if the student intends to participate in a group or team competition but is not in good academic standing, the student may not attend the conference despite membership representation on a team. The student must consider the academic standing *prior* to participating in the local competition prior to the activity. There are no exceptions to this contingency. The team will either have to forfeit its competition status, or another student may replace the student who is not in good academic standing.
3. P1 students in the fall semester are not permitted to miss class time to attend a conference for any reason.
4. Students should submit a complete request to attend a conference (using the form entitled, “Request from Student to Attend Professional Conference/Meetings”) to the Course Coordinator of an affected course via e-mail no later than **1 month prior to the event**. The Coordinator should respond to this request with a decision within two weeks. If multiple courses are affected, requests should be sent simultaneously to all course coordinators.
5. Prior to permission for attendance being granted, the Course Coordinator and student must agree to a specific mechanism for the student to cover missed class content and assignments.
6. If one conference/meeting is attended by more than 6 students per course, a student body officer representative attending the meeting shall compile a list of these students and submit the list with the “Request from Student to Attend Professional Conference/Meetings” forms for each student. The Course Coordinator will choose to communicate with the student officer or each individual student.
7. This policy excludes absence from IPPE or APPE rotations. Excusal from rotations is subject to approval by the Office of Professional Experience Programs and the respective rotation preceptor.

8. Faculty and students may submit written formal proposals to have events added to the Proposed Approved Professional Conferences/Meetings list. Proposals must be submitted by June 1st preceding the academic year in which the event will take place. Formal proposals must be submitted to the Senior Associate Dean of Academic and Student Affairs. The Senior Associate Dean of Academic and Student Affairs will review the proposal and inform the applicant of the decision within one month of receiving the proposal.

## Section VI. PROFESSIONALISM

Email is the primary mechanism for sending official communications to students at the University of Southern California. All students are assigned an official university email address that will be maintained in the university's email directory for at least one year after the student's last enrollment at the university, except in the case of expelled students, whose email access will terminate upon the effective date of their expulsion. Students, therefore, must check email regularly in order to stay updated on important messages and notifications. Failure to read official university communications sent to students' official email addresses does not absolve students from knowing and complying with the content of official communications. Students may forward their email from their official university email address to another email address of their choice. The university, however, is not responsible for email forwarded to another email address.

Students at USC Mann are considered professionals and thus must conduct themselves appropriately in all interactions including via email. It is important that students follow general email etiquette standards for professional communication as outlined below:

1. Meaningful subject line  
Subject lines should accurately describe content giving reader concrete reason to open the message. Subject should be specific to avoid spam-blocker programs
2. Formal writing  
Messages should always be written with formal grammar and writing. Informal writing is reserved only for close friendships or colleagues
3. Focused message  
The purpose of the message should be clearly addressed and polite. Emails should be organized to one subject and limited length. Unrelated points can be split into separate, purposeful emails.
4. Identify yourself  
If the person you are emailing has never interacted with you, introduce yourself in the first few sentences. If you are following up on a face-to-face contact, provide specifics to clue their memory. Identification is not necessary if the receiver knows you well enough to recognize your email address. An email signature block should always be included (see below)
5. Respond promptly  
Emails should be responded to within 48 hours. If you are unable to act on an email, respond to the email to acknowledge you have at least received it
6. Show respect and restraint – sending and responding  
Make proper use of “reply all” when it is important that all who are CC'd to an email receive your message. Likewise, properly use “reply” to prevent unnecessarily inconveniencing others. Spend proper time proofreading the addressees, subject line, content, spelling, and grammar of your email prior to sending

## EngageSC

Students who are interested in attending professional events hosted by USC Mann are expected to register via [EngageSC](#). Students who do not register via EngageSC should understand that they may be barred from an event subject to event capacity or event facilitator discretion. Priority to events will be given to those who have successfully registered. Likewise, registering is considered a commitment to attend and students who fail to attend after registering may be barred from future USC Mann events at faculty discretion or be reviewed for Conduct Violations per Student Handbook.

## Inappropriate emails

While not an exhaustive list, the following uses of e-mail by individuals or organizations are considered inappropriate and unacceptable. In general, e-mail shall not be used for the initiation or retransmission of:

- **Chain mail that misuses or disrupts resources** - E-mail sent repeatedly from user to user, with requests to send to others;
- **Harassing or hate-mail** - Any threatening or abusive e-mail sent to individuals or organizations that violates university rules and regulations or the Code of Student Conduct;
- **Virus hoaxes**;
- **Spamming or e-mail bombing attacks** - Intentional e-mail transmissions that disrupt normal e-mail service;
- **Junk mail** - Unsolicited e-mail that is not related to university business and is sent without a reasonable expectation that the recipient would welcome receiving it; and
- **False identification** - Any actions that defraud another or misrepresent or fail to accurately identify the sender.

## Online Etiquette and Conduct

The online classroom, though very different for many of us, still constitutes a classroom and the decorum should remain the same. Please keep in mind these guidelines for interacting with your peers and instructors in the online environment. Use these guidelines as a foundation for establishing the norms and rules of conduct you would like your group to abide by for the semester.

### Professionalism for Online Courses

---

- Always use a respectful tone when interacting with your classmates and instructors
- Please keep your video on during the sessions to demonstrate ongoing participation and engagement
- Avoid interrupting others – consider using the ‘Raise Hand’ option to indicate your desire to contribute
- Ask clarifying questions if you don’t understand – chances are your classmates are also confused!
- Discussion is welcome and encouraged and should build on each other’s contributions – respond to the content, not the individual
- Avoid monopolizing the discussion
- Everyone should be an active participant in the discussion
- Take responsibility for the quality and direction of the discussion
- Limit any distractions, including background noise or offensive/distracting backgrounds
- Eating is discouraged during the session, though is permissible provided it is not disruptive
- Avoid side conversations in the chat box or other non-Zoom messaging systems
- Arrive on time for every session
- No unprofessional dress (e.g. no wearing pajamas)

## DRESS CODE for Professional Activities

Professional activities may include but are not limited to: introductory and advanced pharmacy practice experiences (IPPEs and APPEs), case conferences, health fairs and other professional events or activities.

USC students are expected to maintain certain standards of appearance during all patient care activities and when otherwise requested to do so (e.g. simulated clinical activities, labs, etc.). Students who are in violation of the dress code may be subject to action including, but not limited to, dismissal from the activity per faculty discretion. While in other practice settings, students may be held to different dress codes.

### All students must meet the standards for appearance as outlined below:

1. Students should dress in well-fitting business or business casual attire with their white coat while at a practice site. White coats must be clean and neat. Examples of acceptable attire include:
  - a. Dress shirt with or without plain tie (solid, stripe, or simple pattern)
  - b. Dress slacks or knee-length skirt
  - c. Close toe shoes with heel < 2.5 inches
  - d. Scrubs may be appropriate depending on the practice site and if approved by the preceptor
2. USC nametag should be worn at all times on the upper body
3. Long hair must be tied back when performing physical exams and when otherwise necessary. Facial hair should be trimmed and neat.
4. Jewelry should be kept simple and minimal.
5. Nails must be short. In most clinical settings acrylic or other artificial nails are not appropriate.
6. Personal hygiene must be maintained.

### Examples of inappropriate attire/appearance:

1. T-shirts, tank tops, jeans, shorts, athletic wear, or sneakers

2. Sandals, bare feet, or any shoes that expose the feet
3. Bare midriffs, tank tops, or tube tops
4. Short skirts, tight fitting clothing such as leggings, and clothing that reveals skin when leaning, stretching, or bending over
5. Wrinkled, torn, or visibly stained clothing
6. Visible tattoos (tattoos should be kept covered when possible)
7. Hats or caps (headwear worn for religious purposes is acceptable)
8. Personal products such as cologne, hair products, and body lotion with a strong scent
9. Attire with distracting organizational names or logos
